

NATA T-28 Formation Clinic at Sheboygan, WI (KSBM)

Thursday July 21 - Monday July 25, 2011

The clinic brief will be at 0800 Friday July 22 and we would like everyone who wishes to fly in the clinic to attend.

We will again have exclusive use of the Aviation Heritage Center, our own reserved ramp space immediately in front of the AHC, and significant fuel discounts from the FBO.

To participate in the clinic, all pilots and guests must sign the waiver. Pilots must also submit a Certificate of Insurance naming NATA as an additional insured. No exceptions.

There will be waived airspace at 3:00 PM Sat & Sun for practice and re-qualifications.

FBO: Burrows Aviation 920-467-6151. Place your order for engine oil with Mindy at Burrows no later than June 1. Plan to purchase all the oil you order when you register at the FBO for fuel. The ramp has tie down rings, but bring your own ropes.

NATA FAST CLINIC KSBM 2011

AGREEMENT TO RELEASE, DEFEND, HOLD HARMLESS, and COVENANT NOT TO SUE

I, the undersigned, desire to participate in flying and social activities held at the Sheboygan County Airport, WI and other activities related to the T-28 NATA/FAST CLINIC KSBM. My participation is purely voluntary and on my own initiative, risk and responsibility. I acknowledge the inherent risks involved in formation flying, and in consideration for being permitted to participate in the flying and other activities, I voluntarily assume any and all risks of injury, death or property damage while participating in the flights, training or other activities whether as pilot, passenger or as an invitee at the Sheboygan County Airport, Sheboygan, WI. I have discussed those risks with my family members, dependents, and any potential beneficiary who may otherwise have a right of recovery in the event of my death or injury, and all have acknowledged and agreed to accept those risks. I am in compliance with all applicable Federal Aviation Regulations, have all required permits and licenses, and will abide by the guidelines established by FAST. My aircraft is in good and safe condition. I possess the requisite skill, physical fitness, and mental condition to participate in the flying activities and do not rely in any way on any of the Released Parties named below to make an assessment in this regard.

I do hereby, for myself, my heirs, executors, representatives, administrators and assigns, release and forever discharge and hold harmless, the North American Trainer Association ("NATA"), Formation and Safety Team ("FAST"), the event organizers and instructors, the county of Sheboygan, WI., Sheboygan County Airport, Aviation Heritage Center, Burrows Aviation, and all their administrators, members, officers, agents, directors, shareholders, servants, employees, volunteers, sponsors, and contributors, (hereinafter jointly referred to as "Released Parties") acting officially or otherwise, from any and all claims, demands, actions or causes of action, even if caused by negligence of the Released Parties, which may arise out of or relate to my participation in the flying or social activities in whatever capacity, related to the NATA FAST Clinic at Sheboygan County Airport.

I hereby waive any right to litigation against the Released Parties, and if this provision is deemed unenforceable for any reason, I agree to resolve any dispute that might arise through binding arbitration under the rules of the American Arbitration Association. In the event any suit is brought on my behalf against any of the Released Parties, I agree for myself, my executors, administrators, heirs and assigns to defend, indemnify and hold harmless the Released Parties, and that any of the Released Parties shall be entitled to recover all attorney's fees and expenses incurred to resolve any dispute initiated by me or anyone purported to be acting on my behalf.

I am of legal age. I received a copy of this release in advance and I have carefully read this release and fully understand its contents. I am aware that this is a contract and sign it of my own free act and deed. Further, I agree that this Agreement will govern any claim arising out of or from my participation at NATA FAST Clinic. If any portion of this agreement is held to be invalid or unenforceable, the balance of the agreement shall remain in full force and effect.
